- I may not copy, distribute, disseminate, publish or broadcast the data in any format, including on the Internet, without written consent. Raw data supplied by the AWPD, whether sensitive or not, may not be published as appendices or tables in public documents without written permission from AWPD.
- I will inform all of the AWPD administrators of any publications or reports emanating from use of AWPD data. A copy of any such publication or report will automatically be supplied to the AWPD administrators free of charge.
- I will acknowledge the AWPD in full in accordance with generally accepted academic referencing guidelines and principles in all parts of any series of publications or reports arising from the project in which the dataset, or information derived from it, was used. The source of the data will be acknowledged as the "African Wildlife Poisoning Database, the Endangered Wildlife Trust and the Peregrine Fund."
- I confirm that all data requested will be used for legitimate and legal purposes.
- I confirm that to the best of my knowledge neither I, nor any of my colleagues who may have access to data obtained from the AWPD, have been investigated or convicted of any form of wildlife crime.
- I confirm that, to the best of my knowledge, neither I nor any of my colleagues have been responsible for any misuse of data.
